



**RULES
OF THE
LONG RANGE MYKITA
COMPETITION**

1. GENERAL PRINCIPLES

1.1 The aim and purpose of LONG RANGE MYKITA is to promote practical, precise rifle shooting over long distances, exchange of experience and best practice of shooting and integration of sportsmen and servicemen. The Competition also aims at raising the level of professional qualifications of officers and servicemen and to propagate this type of shooting among civilian enthusiasts. At the end of the Competition the best shooter will be determined.

1.2 Shooting Club KRYZA, SPRZYMIERZENI z GROM Foundation and Military Sport Club Poligon Drawski are the organizers of the Competition.

1.3 The Competition will take place on 8 - 9 August 2020 on military training area Centrum Szkolenia Wojsk Lądowych Drawsko

1.4 Long Range Mykita is the competition for the Cup of the Commandant of the Land Forces Training Center on the occasion of the Polish Army Day.

Entry fee: 113 EURO/ 500 PLN. At the buy-in price insurance, regeneration meal on 8th August.

1.4 WEAPON:

- Centerfire cartridge firearms of the following calibers: 223 (5,56 mm) up to .338 LM. (8,6 mm)

- Weapon divided into classes:

TACTICAL: calibers .223 and .308;

OPEN: other calibers up to and including .338 LM;

SEMI-AUTO TACTICAL: semi-automatic weapons in .223 and .308 caliber. This class will be created with a minimum of 10 competitors. In the event of failure to create the SEMI-AUTO class, an increase of 25% in the time obtained from the course, without penalties and user bonuses will be added, firing with semi-automatic weapons in the TACTICAL class;

SEMI - AUTO OPEN: In the event of failure to create the SEMI-AUTO class, an increase of 25% in the time obtained from the course, without penalties and user bonuses will be added, shooting with semi-automatic weapons in the OPEN class

1.5 The competition is open to companies, institutions and individuals with appropriate firearms licenses that have registered within the time limit and paid the registration fee.

1.6 Any competitor who, for technical or other reasons, does not intend or can not proceed to another stage or intends to leave the competition area is obliged to report such a fact to the Main Referee under threat of disqualification from the whole competition.

2. SAFETY RULES

2.1 The competitors are required to follow the safety rules, act according to the rules of the Competition, description of the firing lines and observe the principles of Fair Play.

2.2 All participants in the competition are obliged to use –eyes and ears protection equipment during shooting.

2.3 Any weapon during the competition shall be discharged, ie:

- without a cartridge inserted into the cartridge chamber of the weapon;
- without a magazine attached, if the weapon is equipped,
- with the barrel pointing up or down,
- always with the lock in the back position or the safety flag inserted into the cartridge chamber.
- weapons can also be carried in cases or covers. Any other action with the weapon can only be carried out at the command of the Referee with the barrel facing the direction indicated by the Referee or in the Safety Area (SA).

2.4 Safety Area (SA) – clearly marked, safe place for tests, practice/exercise, checks/inspection, cleaning and repair of firearms. It is forbidden to use any kind of ammunition, its parts (e.g. cartridge cases) or dummies in the SA on the penalty of disqualification.

2.5 Secure Weapon/ Safe weapon - a firearm with all safeties switched on.

2.6 Disarmed weapons/ Unloaded firearm – a firearm with its chamber empty and its magazine unattached.

2.7 Stage run - from the Referee standby command: "Ready" and the following timed beep until the judge announces the "End/ break fire".

3. FIREARMS AND EQUIPMENT OF A COMPETITOR

3.1 Obligatory minimum competitors equipment during the Competition:

- weapon;
- eyes and ears protection equipment during shooting;
- hunting pastor or monopod. It can be improvised;
- min. 200 ammo rounds to properly shoot all targets with the first shot.
- a mask or bandama / scarf covering the competitor's mouth and nose.
- hand sanitizer.

3.2 The competitor shall be fully responsible for the equipment, weapons and ammunition used by him during the competition. Each item of equipment and weapons used by the competitor during the competition must be fully operational so that the competitor fully controls them and thus does not jeopardize the safety of other competitors.

3.3 Weapons, ammunition and equipment must meet safety requirements and shooting regulations.

3.4 During the whole competition the competitor must use the same weapon.

3.5 In case of any doubt, the Chief Referee decides on the compliance of the competitor's weapons and equipment with the safety regulations and the rules of the competition, and his decision in this respect is final.

3.6 Ammunition: it is strictly forbidden to use tracer ammunition, armor-piercing ammunition, incendiary ammunition not approved for sport shooting.

3.7 The player during the briefing, prior to the start of competition, is obliged to have all the equipment to run all the stages. Player must have it with him at all time during the competition.

3.8 Any piece of equipment left on the track and not recovered by the player during the course of the track shall be considered lost and not be used in further competitions.

3.9 It is allowed to use: bipods attached to the weapon, bipods for F-Class / Benchrest shooting, backpacks as weapon stands, shooting pads etc. GPS, windometers, laser rangefinders, sextants, ballistic computers, calculators (those in watches also ☺) etc.

3.10 Any doubts about equipment will be resolved by the Chief Referee, whose decision is final.

4. COURSE OF THE COMPETITION.

4.1 During the Competition competitors will not only have to be proficient in safe and skilful handling of firearms but also will have to be physically and mentally fit.

4.2 Shooters will be required of the ability to shoot from different stances, after physical exercise, at unknown distances, and for a limited time.

4.3 On the course of the stage, the competitor shall be informed prior to the start of the course in writing (track description card) or oral (handed over by the shooting Referee on that track).

4.4 Types of targets used during competition:

- paper targets;
- metal targets.

4.5 The result of the player on the track is expressed as the sum of points for the run time and the sum of the points scored for the hits. All of the penalties and bonuses that have been awarded by him shall be added or subtracted from the total stage time of the player.

4.6 Time taken by the player on the track - expressed in seconds, is converted into percentages in relation to the best result, in his class, on a given track, which as a reference is 100%. Percentage means the number of points scored on a given track by a competitor (eg: if a competitor X scored a total of 60 seconds and a competitor Y scored on the same

track scored 50 seconds, the competitor Y gains 100% and 100 points respectively and the competitor X 83.3% and 83 points respectively).

4.7 Hits on the track - expressed in points, are converted into percentages in relation to the best result, in his class, on a given track, which is 100% as a reference point. Percentage means the number of points scored on a given track by a competitor (eg: if a competitor X on track No 1 has a total score of 9 points and a player Y on the same track has a score of 7 points, then a competitor X receives 100% and 100 points respectively and Y competitor 77.7% and respectively 78 points).

4.8 The result of the competitor in the competition is obtained by summing the score of the competitor from all stages. The player who scored the most points wins. All results are given to one decimal place.

4.9 If the competitor does not start in a stage at all, he will score 0 points.

4.10 Detailed stage descriptions will be presented to competitors on the day of the competition. Distances on which targets will be set from 5 m to 1200 m.

5. DISQUALIFICATION (DQ)

- 5.1 Each time a disqualification of a competitor is pronounced this decision has to be approved by the General Referee of the Competition.
- If a competitor deliberately takes off his eyes or ears protection equipment during his performance he will be disqualified.
- 5.3 A competitor will be automatically disqualified if he violates the safety rules and specifically if he:
 - „Makes use of his firearm” outside the SA or when he is on a firing line under the supervision of a Referee following his commands,
 - Allows, during his performance of the firing line, that the muzzle of his firearm is pointed in the direction different form safety angels,
 - Allows a situation that the axis of the barrel of a firearm cuts any part of competitor’s or judge body during a performance (so-called *sweeping*).
 - Does not keep his finger off the trigger when not firing (maintaining trigger discipline),
 - Does not keep his finger off the trigger when moving around; except for when firing in motion,
 - Uses live ammunition or dummy ammunition (including training cartridges, cartridge cases and dummy cartridge) loosely or in boxes, in magazines or in pouches in the SA,

- Carries loaded firearm with a magazine in at any moment except for when following the commands of the Referee on the firing line or when conducting trial runs or exercises with empty magazines in the SA,
- A competitor can also be disqualified if he fires an accidental shot. A shot caused by the firearm's malfunction is not considered accidental. A performance interrupted by an accidental shot will not be continued (the performance will be judged by its actual state); if the malfunction is confirmed by the General Referee of the Competition then the competitor will be able to continue to compete on other firing lines once the malfunction has been repaired.
- A competitor may also be disqualified for foul play or unacceptable behavior or use of unlawful equipment which the General Referee of the Competition deems at variance with the rules

6. FINAL RULES AND ATTACHMENTS

6.1 If any doubts or situations not described in the rules arise during the competition, the final and final vote shall always be held by the Chief Referee.

6.2 Competition will be held irrespective of prevailing hydrometeorological conditions.

6.3 Competitors take part in the competition on their own responsibility.

6.4 In case of withdrawal after registering and paying the fee, the participant is not entitled to reimbursement.

6.5 If the training ground is closed due to excessive drought in the shooting area, the organizer is not responsible for it. In this case, competitors are not entitled to a refund of the entry fee.

6.6 Privacy policy: pursuant to the article 32 of the Act of August 29, 1997 on the protection of personal data (journal of Law of 2002, No. 101, item 926 with amendments) a competitor by sending his registration form allows that his personal data is processed for the organizational purposes of the Long Range Mykita Competition.
